Dorney Residents: Hire Charges

Over the years, Dorney Residents have contributed substantial amounts of their money to Dorney Village Hall.

Firstly, when it was built in 1970, they contributed over £100,000 (in today's money) towards the construction of the Hall.

Secondly, in 2013, Dorney Residents voted in favour of paying an increased Parish Precept, as part of their Council Tax, in order to refurbish Dorney Village Hall totalling over £90,000 (in today's money). Without this investment, Dorney Village Hall would, almost certainly, have been forced to close.

Given this significant support and commitment by Residents, the Dorney Village Hall Management Committee agreed to give Dorney Residents a discount on Hire Fees. We are sure that all Hirers of Dorney Village Hall will understand and agree with this decision.

Definition of Dorney Resident:

Those who live in properties in Dorney and pay, as part of their Council Tax Bill, the precept to "Dorney Parish Council" shown as Line 6 of the charges on the Bill.
